GROUPS DO NOT SEND CHANGES TO WSO!!!!!

DO YOU KNOW HOW TO MAKE Al-Anon Group Changes?

SIAFG Group Records Policy: "2. SIAFG Group Records policy is that Area 16 (Southern Illinois Al-Anon Family Groups) will send all group record changes and new registrations to the SIAFG Group Records Secretary. He/She will make changes to the Area 16 SIAFG and WSO records. DRs will have read only access and run reports for their specific districts from WSO. If they find needed changes they will contact the SIAFG Group Records Secretary."

I. <u>Al-Anon Group Changes, Register a new meeting, Making a meeting inactive!</u>

***Use the siafg.org Quick Link under Members' Area to contact the SIAFG Group Records Secretary TO GET STARTED. The Group Records Secretary can send you all documents needed or go to the website following directions below.

- 1. WHAT do you need? <u>A. A GR1 form (Group Records Change form)</u> <u>B. Contact information for</u> <u>SIAFG and your district</u>
- 2. WHERE do you find these? siafg.org website in the Members' Area (Do you know the password? {area16} GR1 form is located at the top of the Group Records Reports. SIAWSC (Southern Illinois Area World Service Committee) members (SIAFG officers, coordinators, delegate, District Representatives, etc.) are located under Area Business.
- **3.** WHO can make the changes? Anyone that the group conscience designates (GR, CMA (current mailing address) or any member.
- 4. **How** do you make the changes? A. Get the GR1 form located at the top of the Group Records Reports. B. Send the GR1 form to your District and the SIAFG Group Records Secretary. If

changes need to be made to the siafg.org website the SIAFG Group Records Secretary will notify the web master. REMEMBER THE SIAFG GROUP RECORDS SECRETARY NOTIFIES WSO.

- II. Annual update reports sent out in the fall from WSO Please send changes or the message of no changes to the SIAFG Group Records Secretary (siafggrprec@gmail.com). The secretary will notify WSO that it has been submitted and make any changes.
- III. Alateen group changes go to the SIAFG Alateen Coordinator, contact information is located on the SIAWSC list or the Quick Link under Member's area.

Why SIAFG Groups DO NOT send changes to WSO!

In 2011 WSO gave the Area Group Records Secretaries (Coordinators) the ability to enter WSO records and make changes directly. Following Tradition 4 each area was given the authority to decide how they wanted group changes done. I contacted the two previous SIAFG Group Records Secretaries for their opinions on what they would recommend. In the spring of 2011 the SIAFG World Service Committee decided to recommend that ALL GROUP CHANGES go through the SIAFG Group Records Secretary. Group changes are not sent to WSO, those changes will be made by the SIAFG Group Records Secretary. The Area Assembly voted on this recommendation and it passed. SIAFG made a temporary change to the SIAFG By-Laws. (It is temporary until SIAFG makes permanent changes with the State of IL.)

If your group has changes, please contact your District and SIAFG. WSO changes will be made the SIAFG Group Records Secretary.

Any or all of these behaviors **IS NOT** healthy Al-Anon sponsorship, violates trust and feeds on the defects of character that got us to Al-Anon. It attracts the lonely, desperate newcomers who don't feel wanted or needed by anyone. We need to **talk** and **talk** about this cult type of behavior to let members know this is WRONG and THIS IS NOT AL-ANON! Read our "Sponsorship What It's All About," pamphlet P-31 and stress loving guidance, not control/pressure in sponsorship.

Articles

Dominance

Our Service Manual (p. 24) names dominance as one of the three obstacles to success in Al-Anon. It states: "No member should direct, assume authority, or give advice." Resisting the urge to question, comment on, critique, or respond directly to what another Al-Anon member shares can be a challenge—especially when we have something we <u>know</u> they <u>need</u> to hear! It can be particularly tempting to offer unsolicited advice to newer members. But when we set ourselves up as "experts" we not only demean and disrespect the member(s) with whom we are sharing our all-knowing expertise, we destroy the equality and unity that are the spiritual basis of Al-Anon as a whole. The principle of anonymity suggests that every Al-Anon member deserves to be treated with respect and courtesy. Warranty Two of our Concepts states that no "member shall be placed in unqualified authority over other members." Part of practicing these principles is being able to listen respectfully.

Another threat to our unity can come in the form of two or three members speaking back and forth during the meeting, effectively creating a "clique" and excluding the other members of the group who become an audience rather than participants. Concept Four reminds us that "Participation is the Key to Harmony." There can be no true harmony in a group where a small minority is allowed to dominate.

Ideally, our groups should give every member an opportunity to share without fear of judgment or personal commentary. We demonstrate respect for ourselves and our fellow members when we allow each other the dignity to learn from our own mistakes; when we create an environment where we are all safe to share our struggles as well as our solutions. Regular study of our Traditions, Concepts, and our Service Manual can help us avoid dominance in our groups and within ourselves.
